

AUTHENTICATION OF SIGNATURES AND SEALS

Pursuant to Provision § 90 s. 3 Act No. 111/1998 Sb., The Higher Education Act, ITB requires the authentication of signed and sealed diploma originals.

The way of the authentication of signed and sealed diploma originals is in competence of the country where the applicant completed his/her foreign education, i.e., the country where the diploma was issued.

***Requirements for authenticating submitted documents according to different countries:**

A – Apostille is a clause attached to official document that authenticates their signature and seal to be applicable abroad. The clause substitutes super legalization in cases stipulated in international conventions, including the Convention on the Abolition of Legalisation of Foreign Documents from 5th October 1961. In such a case, the document is not subject to authentication by the Czech embassy, but the country where the document was issued, i.e., the apostille body.

B – Authentication of the university diploma is not required; an agreement to provide legal services is available

L – authentication of the university diploma pursuant to § 90 s. 3 the Higher Education Act – super legalization (i.e., authentication by a foreign office or the Ministry of Foreign Affairs of the foreign country and the Czech embassy in the country of the residence of the university issuing the diploma).
